 - Director McIntire led the Pledge of Allegiance.

- 2. iFlow Energy Solutions Presentation: Radio Meter Project: Presenter Omar Figueroa: Power Point Presentation.
 - Mr. Figueroa has been with Kamstrop for 5 years
 - Kamstrop has been "Ultrasonic" and the leader since 1991.
 - Beginning February of 2018, they opened a manufacturing plant in Roswell, Georgia.
 - Currently only 5/8, 3/4, 1-inch and 2-inch meters being built in USA, all other sizes in Denmark.
 - 3" meters available in USA August 2018
 - 4" meters available in USA: later in the year
 - 6' and 8" meters available in USA: Late 2019.
 - Meters are built by Robots.
 - 0.1% failure rate
 - POS Displacement
 - MUIZI Set
 - Electromagnetic
 - Transit time low flow accuracy
 - 20-year battery and meter warrantee
 - No water can get into the electronics
 - RTD Ambient and water temp.
 - Can choose temperature alert to be 36 or 43 degrees
 - Capture Low Flow reduce rate increase
 - Low water loss
 - Increase in revenue
 - .015 GPM 80% recovered
 - Better Conservations
 - Decrease Maintenance
 - 1. 27 GPM = 5/8
 - 2. $30 \text{ GMP} = \frac{3}{4}$
 - Return on investment in 2 years
 - Composite will be in the bid for 5/8 and 3/4, Bronze are more expensive.
 - AMR and AMI both options available
 - o AMR = drive around for reads
 - o AMI = 2 way transmitting, needs licensing.
 - o Easy to switch from one to the other

- 460 days data storage if only getting reads daily
- 100 hours data storage if receiving data multi times a day
- 2100 PSI before meters burst
- Data Collectors up to 10 miles
- Can configure flow rates for leak alerts etc. upon installation or later
- Intelligent Power management so batteries don't wear down
- Self-configures
- Will hire out for installation
- Approx. 2K per year for software support, Mr. Figueroa will double check
